## POST OF TECHNICAL OFFICER (ELECTRICAL) (ON CONTRACT)

### 1.0 Job Responsibilities:

#### Position 1

- Assisting the implementation of new construction and renovation projects undertaken by the Bank.
- Assisting the feasibility studies for new electrical infrastructure facilities, upgrading/expansion of existing electrical systems and implementation of those plans to ensure the availability of infrastructure facilities and services required for the smooth operation of the Bank.
- Assisting the management of construction, renovation and infrastructure development/upgrading projects.
- Supporting the administration of contracts related to consultancy services.
- Assisting the procurement process related to construction, renovation and infrastructure development/upgrading projects of the Bank.
- Assisting and providing technical inputs for the procurement process of other departments.
- Checking the payment requests and making recommendations.
- Preparation of BOQs for contracts and site supervision.
- Assisting the Board of Survey process.

#### Position 2

- Assisting the preventive maintenance of all the electrical plant and equipment and electricity distribution systems installed at buildings belong to CBSL.
- Assisting the administration of contracts related to operation and maintenance of electrical building services, infrastructure, plant and equipment.
- Assisting the procurement process related to maintenance of mechanical building services, infrastructure, plant and equipment.
- Assisting and providing technical inputs for the procurement process of other departments.
- Checking the payment requests and making recommendations.
- Preparation of BOQs for maintenance services and site supervision.
- Assisting the Board of Survey process.

### 2.0 Required Minimum Qualifications & Experience:

National Diploma in Technology (NDT)/ Higher National Diploma in Engineering (HNDE)/ National Diploma in Engineering Sciences (NDES) or National Vocational Qualification (NVQ) Level 5 specialized in the field of Electrical.

**AND**

Post qualification work experience of not less than 10 years, preferably in the field of construction / renovation projects related to building services and building maintenance.

**Applicants are strictly advised to submit copies of the certificates relevant to the educational/professional qualifications & work experience. Any application without the copies of the above documents will be rejected without any notice at any stage of the recruitment process.**

### 3.0 Age:

Below 40 years of age as at 27.11.2024

### 4.0 Employment:

On contract basis for a period not more than three (03) years. The contract will be initially signed for one (01) year and the renewal of the contract will be considered at the end of each year based on the performance.

### 5.0 Remuneration and Other Benefits:

All-inclusive taxable monthly allowance of Rs. 175,000.00 with contributions to Employees' Provident Fund (EPF) and Employees Trust Fund (ETF).

### Selection Procedure

Candidates will be shortlisted based on their qualifications and work experience. Most suitable candidates for the above post will be selected by an interview/s conducted by the Bank.
