	a) Engineering Degree (Mechanical) – from a University in Sri Lanka <b>OR</b> b) The Institution of Engineers, Sri Lanka (IESL) Part I & II (Mechanical) <b>OR</b> c) Any other qualification recognized as equivalent in the same field by ‘The Institution of Engineers, Sri Lanka’, (Letter of accreditation by IESL shall be annexed).
	<b>C. Civil Engineer Class II Grade II</b>
	a) Engineering Degree (Civil) – from a University in Sri Lanka <b>OR</b> b) The Institution of Engineers, Sri Lanka (IESL) Part I & II (Civil) <b>OR</b> c) Any other qualification recognized as equivalent in the same field by ‘The Institution of Engineers, Sri Lanka’, (Letter of accreditation by IESL shall be annexed).
<b>2. Age Limit</b>	Should not be more than 35 years of age at the closing date of applications (This age limit will not be applicable to those who are in State Service/Statutory Boards including CEB/Corporations, and they are required to forward their applications through the respective Heads of Institutions.)
<b>3. Salary</b>	For those having the Chartered Engineer qualification either through IESL or IET (UK) Rs. 222,945 5 x 4,035 10 x 4,155 – 284,670/= p.m. (E3). For others Rs. 183,600 5 x 3,295 10 x 3,360 – 233,675/= p.m. (E4).
<b>4. Method of Selection</b>	By an interview However, if a large number of applications received, the applications who fulfill the recruitment requirements as specified, will be called upon to sit for an examination for the purpose of shortlisting of candidates. Selecting suitable individuals for recruitment from the short-listed candidates will be done by an interview.
<b>5. Place of Work (if selected)</b>	Ceylon Electricity Board reserves the right to post the Engineers recruited to any location/s in the country decided by the CEB. Selected applicants will only be recruited if they in writing agree to accept the post at the location decided by the CEB.

1. Any application received after the closing date or does **not conform to the above requirements will not be entertained**. Depending on the number of applications received, they will be shortlisted. Shortlisting will be done by examination if required as per 4 above. The applicants who were short-listed will only be called for the final interview. Any form of written or verbal canvassing is strictly prohibited and such an attempt shall be considered as a reason for disqualification.
