Applications are invited from citizens of Sri Lanka having the qualifications, experience and professional competencies specified below and having previous work experience of environmental management in power sector or other industrial construction projects.

Qualifications:

- Bachelor's Degree from a recognized university in Sri Lanka or any other qualification recognized as equivalent.
- Master's Degree in Environmental Science, Environment Management or any other related field obtained from a recognized University.

Experience:

- A minimum of 10 years of experience on Environmental/ Social Safeguard, Preferably in the construction of roads, power development projects, substations, and high-voltage transmission lines.
- Experience in land acquisition will be an added advantage, especially for Road and Power sector projects.

Age:

- Below 45 years.

- Ability to handle project environment related activities in the required area of specialization independently.
