02. Educational and Professional Qualifications:

Recruitment of External Applicants (01, 02 or 03 below)

(1) Degree recognized by the University Grants Commission with three (03) years post qualification service experience in a Staff Officer Level post of the Government Security Division

Or

(2) Being an Officer who has duly retired from regular force in tri forces after having served in the post of Major or above

Or

(3) Being an Officer who has duly retired from the regular service of Sri Lanka Police after having served in the post of Assistant Superintendent of Police or above

Age : Should be not less than 22 years and not more than 45 years. Maximum age limit will not be applicable to internal applicants.

03. Financial Benefits

- I. Salary relevant to a post in JM 1-1 in Management Services Circular No. 01/2025
- II. Other allowances approved by the Ministry of Finance (Incentives, Attendance Allowance, Transport Allowance, Cost of Living Allowance)
