CISSP and /or CISM or demonstrated technical abilities at this level, CISA, CISM, CRISC, CEH, CompTIA Pen Test+, GIAC Penetration Tester (GPEN), SSCP, CCNA-Security, CySA+, GICSP, GSEC, Certified Identity and Access Manager (CIAM) or Certified Identity Management Professional (CIMP) or related certification

 - Positive mindset with drive and commitment to achieve bank's objective

 - Possess leadership qualities

Selection Procedure

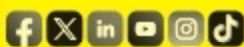
- By an aptitude test and subsequent interview for shortlisted candidates based on the above eligibility criteria.
