Job Description

Purpose:

- Take steps to protect the intellectual property rights of the Group by registering the intellectual properties of the Group where necessary as required by the respective jurisdictions as and when necessary and administering those registrations continuously.
- Provide advice to internal departments of the Group on a day-to-day basis in order to ensure the Group carries out its activities in compliance with statutory requirements, industry norms and contractual obligations.
- Prepare conditions precedent/subsequent to comply with major international contracts in order to ensure that Company honours its contractual obligations.
- Maintain and monitor claims by and against the Group and take appropriate action to defend claims filed against the Group and to recover monies due to the Group from the claims filed by the Group.
- Attend to all conveyancing requirements of the Group.
- To keep abreast with developments in Aviation Law, Commercial & Corporate Law, Law of Contracts and Labour Law and practises, and to monitor and report on the latest air transportation regulatory developments initiated by IATA , ICAO and other international bodies.
